Organisation Overview

Role Statement

Role Overview

The Design Advisor reports to the Team Leader, Design and will provide high-level design analysis, critique and advice relating to development proposals across the State. They key focus areas of the role include:

- Undertake analysis and provide advice relating to development proposals in the design review program.
- Establish and maintain best practice design review processes relating to development proposals.
- Support the development and establishment of frameworks that enable design quality in the built environment.
- Promote the value of design advice.

The Design Advisor will work closely with the Senior Design Advisors, the South Australian Government Architect, Associate Government Architect to establish and maintain to a high standard design review process of development proposals. Key relationships will be with staff within the directorate, internal and external stakeholders including Development Division, other state agencies, jurisdictions and Industry partners.

Key Outcomes of the Role

The Design Advisor is required to undertake a wide range of activities which may include all or any of the following:

- d. Providing high level analysis, research, information and expert advice that will assist in the development of assigned agency programs, projects, systems, policies and/or services.
- e. Undertaking critical, sensitive and/or complex information, consultation and/or negotiation processes with stakeholders and across government agencies.
- f. Coordinating investigations and preparing reports and recommendations on matters of some complexity and sensitivity.
- g. Contributing to a safe, diverse and healthy work environment free from discrimination and harassment by working in accordance with legislative requirements, the <u>Code of Ethics for the South Australian Public Sector</u>, equal employment opportunity and departmental human resource policies, including Work Health Safety and Wellbeing requirements.
- h. Contributing to a high standard of customer service for internal and external clients and quality management and risk.

a. A degree in a design discipline such as architecture, urban design, planning or similar.
