APPLICATION UNDER THE *FREEDOM OF INFORMATION ACT 1991*

I refer to your application made under the *Freedom of Information Act 1991* (the Act), dated 20 January 2023.

Your application seeks access to:

“A copy of all documents (including briefing notes, minutes, letters, emails and any other form of correspondence) regarding a briefing for the Minister for Infrastructure and Transport on 20/06/2022, subject “updated briefing with Keolis Downer” between 19/06/2022 and 24/06/2022.”

An extensive search was conducted within this office. A total of 2 documents were identified as answering the terms of your application.

I grant you access in part to 2 documents; copies of which are enclosed.

Documents Released in Part

Documents 1 and 2 are released in part as it contains specific information on when the meeting is to be held. I therefore determine this information exempt pursuant to clause 6 to the FOI Act.

Document 2 is released in part as it contains mobile phone numbers and if released would involve the unreasonable disclosure of personal information. I therefore determine this information exempt pursuant to clause 6 to the FOI Act.

Exemptions

Clause 6 – Documents affecting personal affairs

- (1) A document is an exempt document if it contains matter the disclosure of which would involve the unreasonable disclosure of information concerning the personal affairs of any person (living or dead).
