**NOTICE OF DETERMINATION - REQUEST FOR ACCESS TO DOCUMENTS UNDER
THE FREEDOM OF INFORMATION ACT 1991**

I refer to your application made under the *Freedom of Information Act 1991* (the FOI Act) received by this agency on 6 March 2023.

You have requested access to the following:

For the period 14 January 2023 to 6 March 2023, documents as defined under Part 1 Section 4 Freedom of Information Act 1991 (SA), pertaining to overseas travel, planning of overseas travel and/or procurement of overseas travel for the Minister or staff within the Office of the Minister for Local Government, Regional Roads and Veterans Affairs.

There is one (1) document that falls within the scope of your application and is that listed in the attached document schedule.

I have determined to refuse access to Document 1 under section 20(1)(b) of the Act which states:

20—Refusal of access

- (1) *An agency may refuse access to a document—*
- (b) *if it is a document that is available for inspection at that or some other agency (whether as part of a public register or otherwise) in accordance with Part 2, or in accordance with a legislative instrument other than this Act, whether or not inspection of the document is subject to a fee or charge;..*
